LEED is a program created and administered by the U.S. Green Building Council[^] for the design, construction, maintenance and operations of high-performance green buildings.

LEED points are given to building projects that have at least 20 different permanently installed products from at least five different manufacturers that have EPDs and HPDs. Products with both EPDs and HPDs can contribute toward two LEED points: one for an EPD and one for an HPD. Additionally, since PanGen Solutions come from two vendors, they can satisfy two of the five manufacturers required per LEED point.
